FOOTNOTES

- (1) Eurosystem harmonized definitions (see the Methodological Appendix of the "Money and Banking" Supplement to the Statistical Bulletin). The figures refer to the business of Italian banks with counterparties resident in Italy. The growth rates are calculated including loans not stated in banks' balance sheets because securitized and excluding changes in stocks not due to transactions (e.g. changes due to exchange rate variations, value adjustments and reclassifications). The figures for the last month are provisional. In addition to the monthly developments for the reference month, this press release incorporates revisions to the data for previous months. The related time-series are available on the Bank of Italy's website under Statistics/Statistical database (BDS).
- (2) The changes in bank loans and deposits in the twelve months to November 2015 could reflect the effects of varying fiscal deadlines for tax filings, set for 1 December in 2014 and 30 November in 2015.
- (3) In addition to households and non-financial corporations, the private sector includes insurance corporations, pension funds and the other financial institutions; transactions concluded with central counterparties are excluded.
- (4) Includes overnight deposits, deposits with agreed maturity, deposits redeemable at notice and repos; deposits connected with securitizations are excluded.
- (5) Nominal value. As of December 2011 the item includes bonds issued with a state guarantee under Decree Law 201/2011.
- (6) Market value. As of December 2011 the item includes bonds issued with a state guarantee under Decree Law 201/2011.
