## Consolidated financial statement of the Eurosystem as at 10 January 2020

In the week ending 10 January 2020 the net position of the Eurosystem in foreign currency (asset items 2 and 3 minus liability items 7, 8 and 9) decreased by EUR 5.5 billion to EUR 290.6 billion.

As a result of the Eurosystem's open market operations and standing facilities, net lending to credit institutions (asset item 5 minus liability items 2.2, 2.3, 2.4, 2.5 and 4) fell by EUR 14 billion to EUR 374.7 billion.

Base money (liability items 1, 2.1 and 2.2) increased by EUR 31.2 billion to EUR 3,187.5 billion.

The table below provides the detailed breakdown of **securities held for monetary policy purposes** (asset item 7.1) into the different portfolios. All portfolios are accounted for at amortised cost.
