## **Background information**

# Informal Ecofin: meeting of EU Ministers of Finance and Central Bank Governors

Informal Ministerial meetings are traditionally hosted by the acting Presidency of the Council of the EU. This is the occasion for EU high level decision makers to gather in a less formal format than in the Schuman neighborhood. These meetings provide the opportunity to explore important topics, and exchange diverse perspectives on major challenges such as EU competitiveness.

At informal Ecofin meetings the Central Bank Governors are invited to join and discuss together with the Finance Ministers. some pressing European financial topics. This also gives the opportunity to the Ministers and Governors to coordinate their monetary and budgetary viewpoints. The informal nature of these meetings encourages direct communication between Ministers, often allowing for a better understanding of each other's views and concerns.

The informal conclusions of these informal Ministerial meetings are a valuable input for the following day-to-day wors within the EU Council in the field of finance.

### Informal Ecofin on EU competitiveness

As Belgium takes on its thirteenth Presidency of the European Union, we're at a critical juncture. Challenges, both immediate and long-term, are impacting our socio-economic future. The EU is dealing with a considerable competitiveness challenge, not just in how we compete globally, but also in strengthening our internal market.

Addressing this competitiveness challenge is a top priority for the Belgian Presidency and will remain a key focus for the upcoming European Commission. As Ministers of Finance and Central Bank Governors, we will be examining how public and private financing in Europe will be organized in the coming years. Because meeting this challenge will require significant investments from both the public and private sectors. During the informal Ecofin, three major debates will be organised. There will be a debate on the future of the European Investment Bank, a debate on retail investor participation and financial literacy, and a discussion on the report on the future of EU competitiveness as is currenlty being prepared by Dr. Mario Draghi.

### **Detailed agenda**

#### **Topics Eurogroup:**

Discussion on the Future of European Capital and Financial Markets, and on the overall macroeconomic developments and prospects in the Eurozone.

#### **Topic Working Lunch:**

During the Working Lunch on Friday, EU Finance Ministers will have the opportunity to discuss the future of the European Investment Bank (EIB). As current Chair of the Board of Governors of the EIB, Minister Van Peteghem will lead a debate on the future of the European Investment Bank Group. The new EIB President Nadia Calviño is invited to present her vision on the future of the EU's public lender and largest multilateral bank.

#### **Topic Working Session I:**

During the first Working Session on Friday afternoon, in the context of the deepening of the Capital Markets Union, the Finance Ministers together with the Central Bank Governors will discuss the overall financial literacy of EU-citizens and how to improve retail participation in financial markets.

#### **Topic Working Session II:**

On Saturday morning there is a working session dedicated to EU competitiveness, the overarching topic of this informal Ecofin. For this session Minister Van Peteghem invites Dr. Mario Draghi.

At her annual State of the Union on 13 September 2023, Commission President Ursula Von der Leyen tasked Dr. Mario Draghi with the preparation of a report on the future of European competitiveness.

This informal debate will give Dr. Draghi the opportunity to inform Ministers on the preparation of his report but in particular gather input from the EU Ministers of Finance.

#### Press conferences:

The Working Sessions of the Ministers will be closed to the media. In order to inform the press core, a designated press conference is scheduled after the conclusion of discussions of each Working Session.

During the press conferences, a summary of the discussed key points will be provided. This should allow for transparency while respecting the confidential nature of the meeting.
