The Governing Council, at the proposal of the Governor, today named Salvatore Rossi Deputy Director General and thus member of the Bank's Governing Board (Directorate).

Since May of this year Mr. Rossi has been Secretary General and Advisor to the Governing Board on economic policy matters. From 2007 on he had been Managing Director for Economic Research and International Relations (curriculum vitae attached).

The appointment as Deputy Director General, made pursuant to Article 17 of the Bank of Italy's Statute, will become effective with the issue by the President of the Republic of a decree of approval at the proposal of the Prime Minister in concert with the Minister for the Economy and Finance after consulting with the Council of Ministers.

SALVATORE ROSSI

Salvatore Rossi moves to the Governing Board (Directorate) from the position, held since May, of Secretary General and Advisor to the Governing Board for economic policy matters.

In 2007, after seven years as Head of the Department of Economic Research, he was named Managing Director for Economic Research and International Relations. He is a member of the Executive Committee of the Italian Economic Society and of Istituto Affari Internazionali, the Statistical Information Guarantee Committee of the Prime Minister's Office, the Board of Directors of Istituto Adriano Olivetti, and the Eurosystem IT Steering Committee.

Mr. Rossi was born in Bari on 6 January 1949. He graduated from the University of Bari in 1974 with a thesis in mathematical physics and in 1975 won a National Research Council fellowship for applied mathematics. He is the author of many essays on the international economy, economic history and policy, and industrial economics. He has published books on the integration of European markets, on the Italian balance of payments and economic policy, on the ICT revolution, on the way out of the Italian economy's growth crisis, and on the Italian economy in the global crisis.
