NOTE TO THE READER

The work that follows is the fruit of an ongoing survey in view of the production of a systematic, analytical bibliography of Tommaso Padoa-Schioppa's works, published over a span of more than four decades.¹ It was decided in order to present the bibliography as a "work in progress"² to provide the participants at the *Conference in memory of Tommaso Padoa-Schioppa* with a working instrument that offers an initial overview of his intellectual legacy, which can be divided according to theme and related to his activities with Italian and international institutions. The large number of works and their great variety from the bibliographical standpoint necessitated the imposition of some criteria for selection. The organization and description of the material chosen conform to the guidelines set out below.

GUIDELINES

The sources

The survey is based on the writings in the collection held in the Paolo Baffi Library at the Bank of Italy, where Padoa-Schioppa worked from 1968 to 1979 and from 1984 to 1997. This core body has been steadily supplemented by

later works held at other libraries, research centres and international organizations, listed in electronic catalogues and databases, or available directly online.

The works surveyed: selection criteria and bibliographical approach

This bibliography covers works that were published either in the press or online, but it excludes articles that appeared in daily newspapers (except for those published in collections), works for governmental bodies, and public hearings (apart from those published as articles or essays).

However, for conference participants who may be interested, an appendix gives the titles of remarks and speeches printed for use within the Bank of Italy from 1989 to 1997 and not published in another form. In addition, some other speeches given by Padoa-Schioppa are available online on the website of the European Central Bank (<http://www.ecb.int/press/key/speaker/bm/html/index.en.html>) and on his own website (<http://www.tommasopadoaschioppa.eu/archivio/discorsi>).

The bibliographical approach is analytical: there are descriptions of monographs, collections of essays, articles in scholarly journals and more general articles, essays published as part of collections, comments and remarks as discussant, encyclopedia articles, prefaces to other authors' works, and volumes edited by Padoa-Schioppa.

Identification of the works and style of references

The structure of this volume and the style of the references are adapted from those used in preparing *Paolo Baffi: bibliografia degli scritti*, Rome, Banca d'Italia, 2009 (http://www.bancaditalia.it/studiricerche/convegni/atti/paolo_baffi/Bibliografia%20degli%20scritti.pdf).

Reprints and further editions under the same title in the same year have been indicated in the notes; those in subsequent years or under different titles have separate entries. For the main collections of essays in English the notes also specify the original “sources” of each essay.

As for *Paolo Baffi: bibliografia degli scritti*, the definitive version of the bibliography will have a cross-referencing system that will make it possible to link the bibliographical citations of the various editions, reprints and translations of each work.

Organization and order

The works are in chronological order, grouped by year of publication. Each entry is numbered. Within each year, they are in alphabetical order by title, except for prefaces and works edited by Padoa-Schioppa, which are listed separately. For works written together with co-authors, the co-authors are cited immediately after the title.

The group of “prefaces” comprises prefaces, forewords and introductions to works by other authors. The page numbers

of these writings are given in the notes to the full reference entry for each work.

Index

The bibliography has an index by title. Alongside the title is the number identifying each separate entry. The index also specifies whether the work is a preface or an edited volume.
