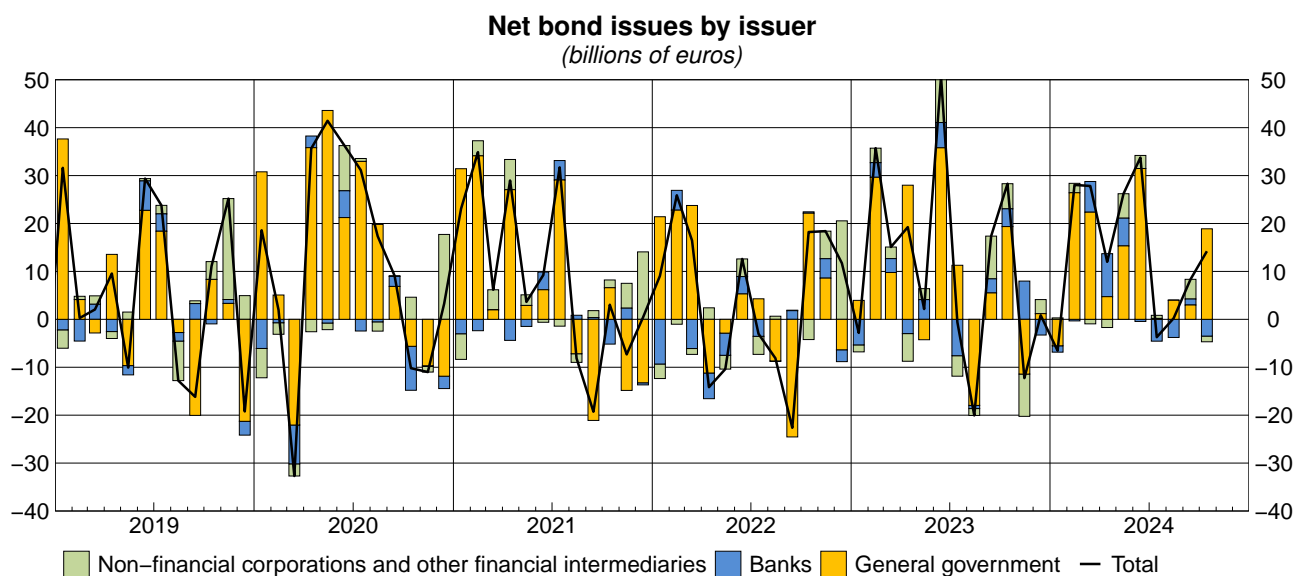

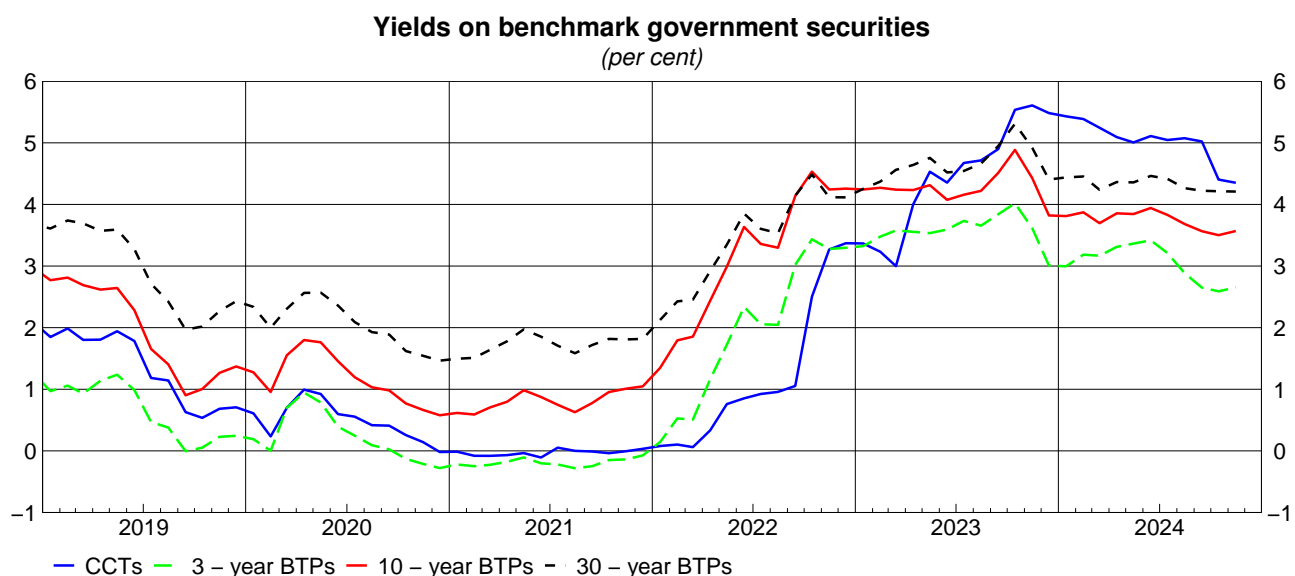

In October resident sectors recorded net bond issues of €14.2 billion. General government recorded net bond issues of €18.9 billion, an outcome to which BTPs and BOTs contributed positively (€32.3 and €1.8 billion, respectively), while CCTs and international securities contributed negatively (€12.9 and €2.3 billion, respectively). Banks recorded net redemptions of €3.5 billion. The net issues of the remaining sectors were negative at €1.2 billion, with other financial intermediaries, non-financial corporations and insurance corporations contributing -€2.7, €0.8 and €0.7 billion, respectively.

In November gross yields to maturity on 3-year and 10-year benchmark BTPs increased by 6 and 7 basis points, to 2.65 and 3.57 per cent, respectively, while the yield on 30-year benchmark BTPs remained unchanged at 4.21 per cent. The gross yield on benchmark CCTs decreased by 5 basis points to 4.35 per cent.

From the publication of June 2023, data on securities issued by residents (table [VALM0100](#)) are compiled, starting from the reference date January 2022, following the principles of the new ECB guideline [2022/971](#). Published data are obtained from ECB Securities Issues Statistics ([CSEC](#)) whose source is the Centralized Securities Database (CSDB). Some details published in the table that can not be obtained from the new source continue to be compiled from the national Securities Register managed by the Bank of Italy. For the details see the "[Methods and Sources: Methodological Notes](#)".
