

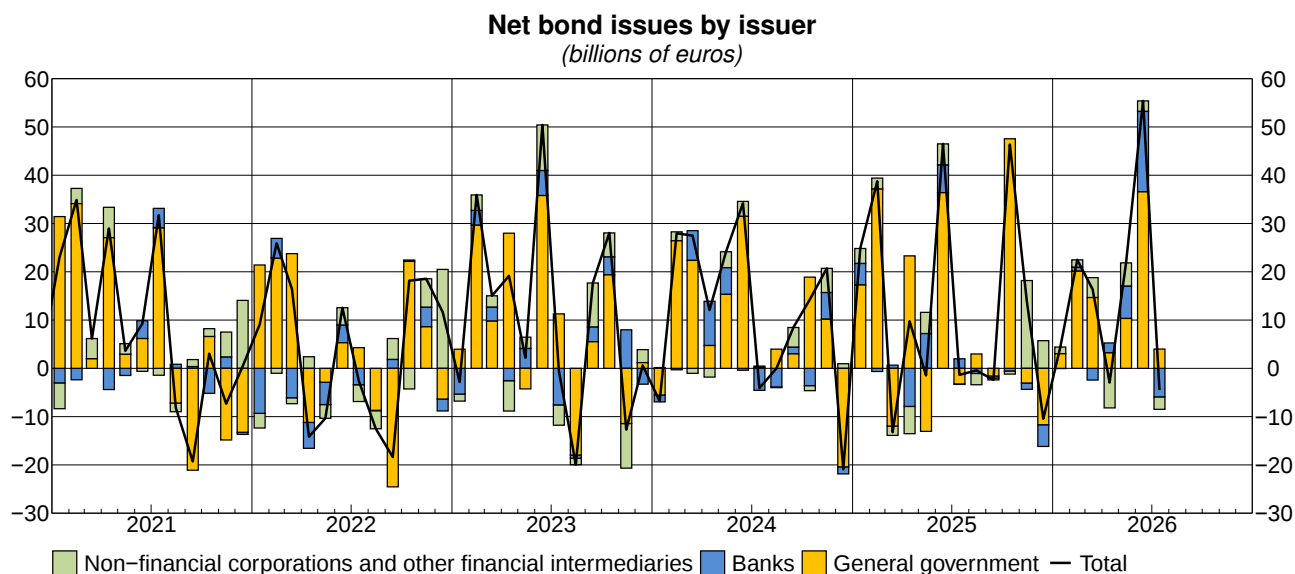

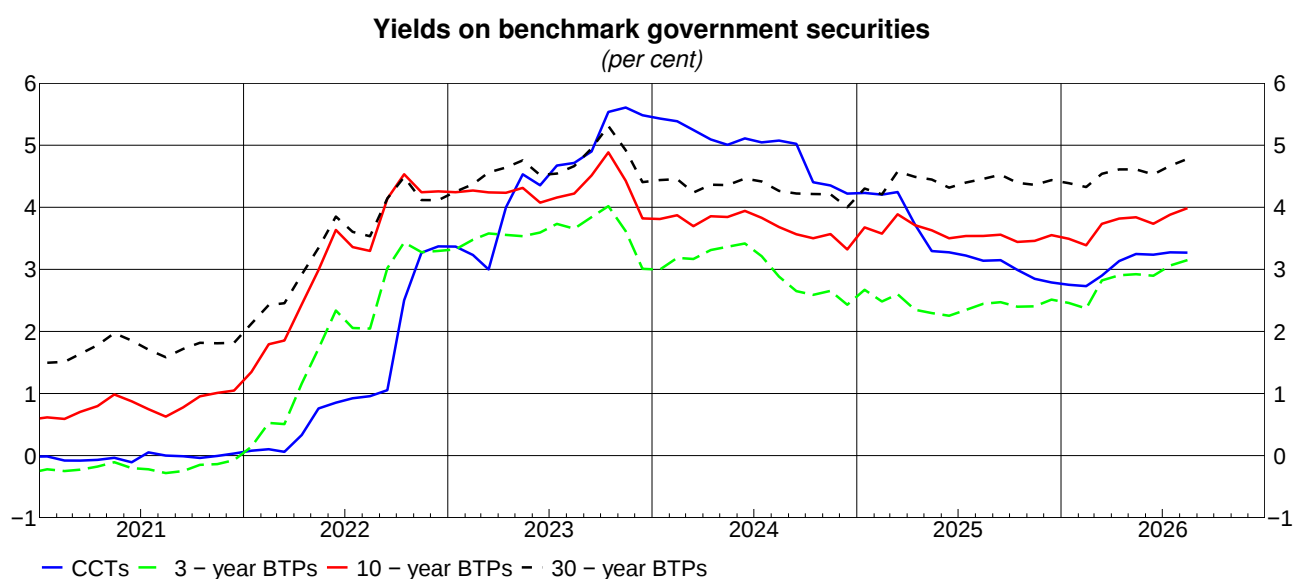

In July, resident sectors recorded net issues of -€4.5 billion. General government net issues were positive at €4.0 billion, an outcome to which BTPs, CCTs and international securities contributed positively (€4.6, €2.2, and €5.2 billion, respectively), while BOTs contributed negatively (-€8.0 billion). Banks recorded net redemptions of €5.9 billion. The net issues of the remaining sectors were negative at -€2.6 billion, with other financial intermediaries and non-financial corporations contributing -€4.2 and €1.6 billion, respectively.

In August, gross yields to maturity on 3-year, 10-year and 30-year benchmark BTPs increased by 9, 11 and 11 basis points to 3.15, 3.99 and 4.78 per cent, respectively. The gross yield on benchmark CCTs remained unchanged at 3.27 per cent.
