INTRODUCTION

This document contains statistics, in some cases no longer measured, of interest for the historical and economic analysis of monetary and financial aggregates. In some cases the figures refer to actual observations, in others they have been reconstructed on the basis of estimates. The nature of the information provided and the procedures used are described in the notes to the individual tables. The data presented may be modified or supplemented in the light of new information that becomes available or for other reasons.

Since some of the series reach far back into the past, it is recommended that readers consult the methodological notes to the publication for information on the statistical and institutional context and the presence of estimates.

Section 1 – Italian monetary aggregates

Methodological notes

Table 1 - TAMS0100 – Components of the monetary aggregates: 1948 - 1998

This table shows the reconstruction of the main monetary aggregates. The values are given in billions of lire and, in the BIP on-line version, are available on a monthly basis.

In reconstructing the monetary aggregates, the aim has been to produce series that are as consistent as possible over the whole span of the reconstruction. Accordingly, a “base” definition has been identified that is a compromise between the various definitions that followed each other over time and that does not excessively penalize the analysis of the aggregates in the different subperiods. The reconstruction of the series on a monthly basis made it necessary to use estimates where the data were available with a lower frequency. These two factors explain most of the differences between the values of the aggregates published here and those that can be derived from the contemporary documents published during the fifty years covered (Figure 1). It should be remembered that the construction of true monetary aggregates for Italy dates back to the early 1970s and that it was not until 1983 that the Annual Report contained a table in which M1 appeared. In 1985 there was the first revision of the monetary aggregate statistics in an article published in *Economic Bulletin*, no. 1, October 1985 (no. 5 in Italian); this set out the criteria adopted in specifying the instruments making up the new variables – M1, M2, M2A and M3 – and provided a clear definition of the holding sector. At the end of 1990 another revision was made, which remained in force until the end of 1998, when, with the start of the third stage of Economic and Monetary Union, responsibility for the definition of the monetary aggregates passed to the Governing Council of the European Central Bank.

Reconstructed aggregates

M1 (S782072M)

This is the most liquid component of money. It is made up of: currency in circulation, bank and PO current accounts and other minor items. In the reconstruction of the component “currency in circulation” it has been assumed, in the absence of monthly data on banks’ holdings of cash for the period 1948-75, that the quantity of banknotes held by the banking system was equal to the stock of coins and notes issued by the Treasury. The component “other items” includes banker’s drafts issued by banks and the Bank of Italy and the social security institutions’ accounts with the Treasury.

M2 (S855789M and S900399M)

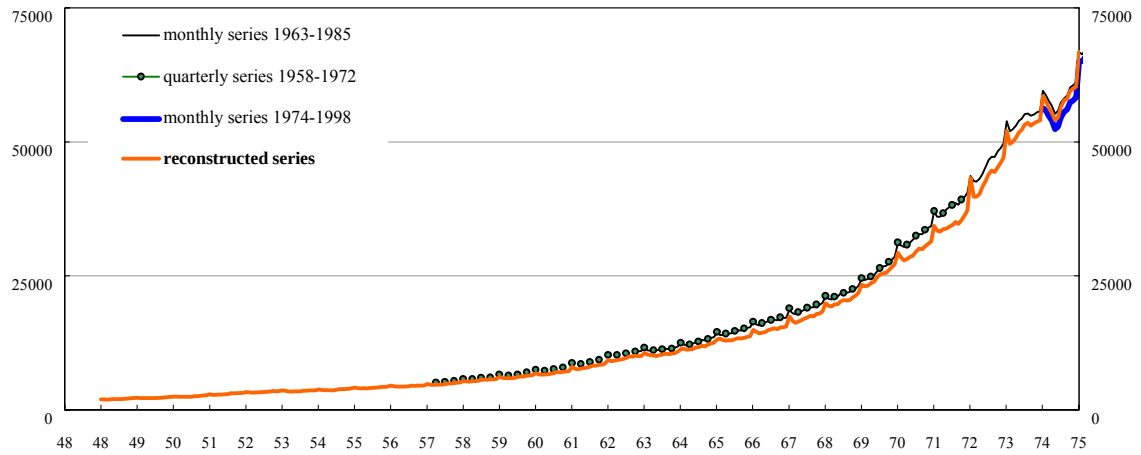
There are two versions of M2. The S855789M series includes M1 and all bank deposits other than current accounts (savings deposits and time deposits) and PO savings accounts. The S900399M series also includes, as of 1983, certificates of deposit with maturities up to 18 months. CDs were first introduced in 1974, but it was only in 1983 that issues of short-term CDs began; the value of the two series was the same before 1983.

M2 PLUS (*S974635M*)

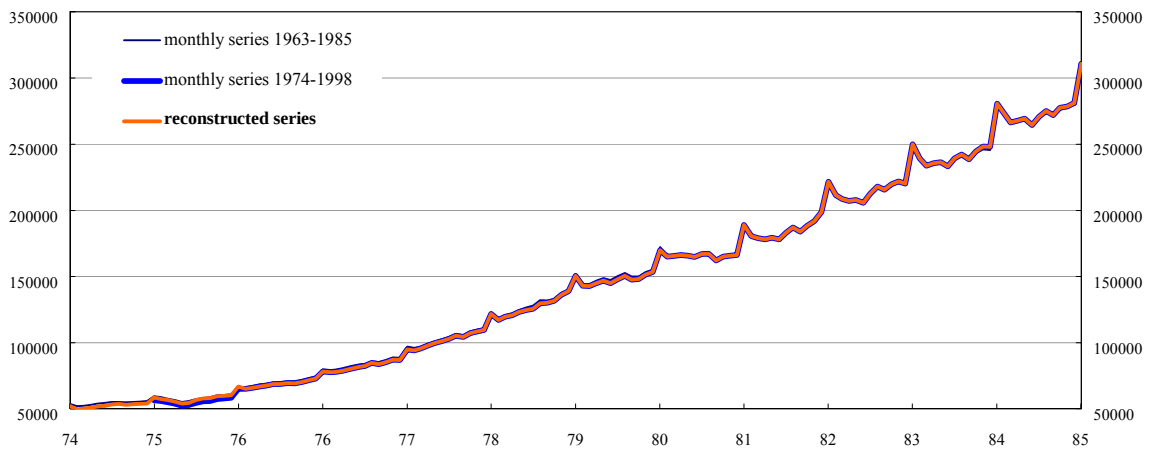
This aggregate has been defined to have an instrument bridging the gap between the aggregate “Liquid assets”, which was the least liquid of the monetary aggregates analyzed up to 1998 and the present harmonized definition of M3. In addition to the items included in the S900399M series, it includes CDs with maturities longer than 18 months, banks’ fund-raising securities deposits with customers and P.O. ordinary savings certificates; in the harmonized definition of the monetary aggregates, the latter are included in M2. The item “liquid assets”, used up to 1998, also included Treasury bills placed with the so-called non-state sector. Figure 2 shows the monetary aggregates according to the definitions used for this reconstruction and the main component instruments (the definitions adopted are given in Figure 3).

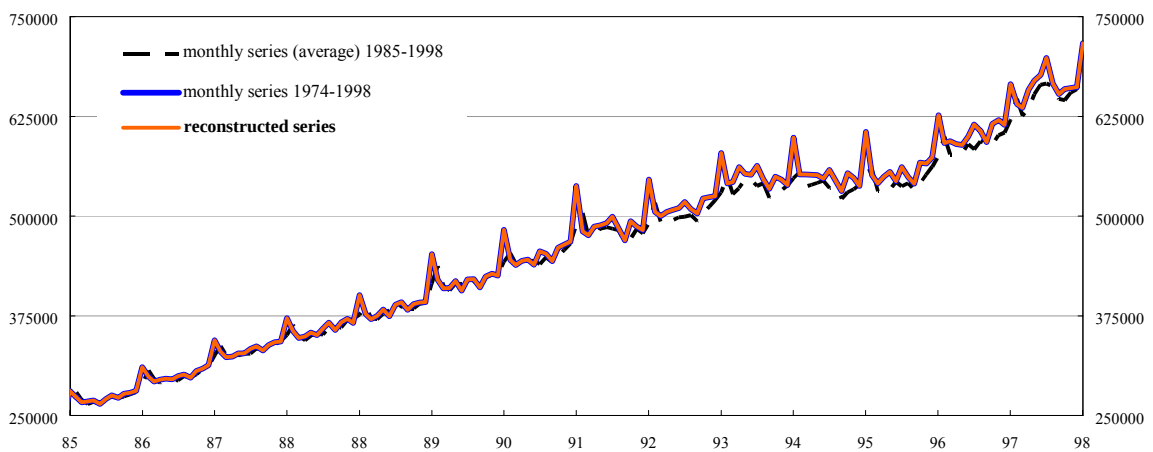
**M1: COMPARISON BETWEEN THE RECONSTRUCTED SERIES

MONEY: DATA FROM 1948 TO 1998

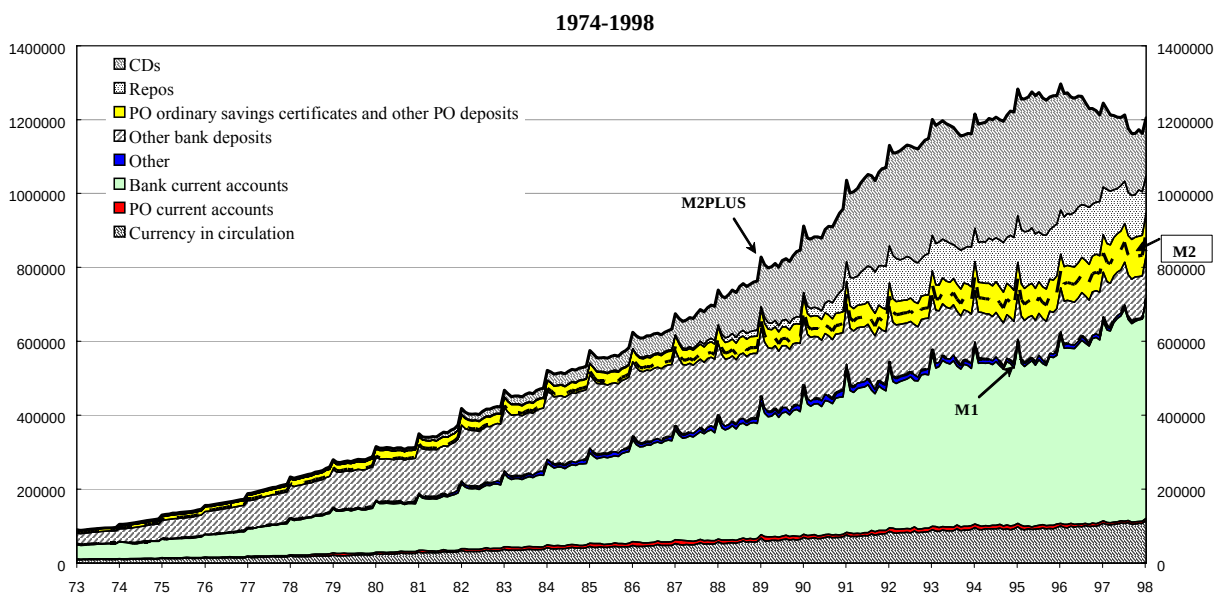

Table 2 - TAMS0110 – Italian Contribution to euro-area monetary aggregates: M3 and Finance to Other residents
definition including repos with central counterparties

This Table contains Italy's contribution to euro-area monetary and credit aggregates computed for the period June 2010 - July 2012 on the basis of the definitions applying at the time, which included repos conducted by MFIs with central counterparties. The statistics based on the new definitions are published in Supplement to the Statistical Bulletin "Money and Banking" starting from No. 49, 8 October 2012.

More specifically, the Governing Council of the ECB issued a decision on 5 July 2012 approving a partial amendment to the definition of monetary and credit aggregates used by the Eurosystem. The new definition came into force in September 2012 and applies retroactively to data from June 2010 on. According to the new definition, the monetary aggregate M3 does not include reverse repos conducted by MFIs with central counterparties, which under the previous definition were included in reverse repos with "other financial institutions". The aggregate counterparts of money "loans to other residents" does not include repos conducted by MFIs with central counterparties, which according to the previous definition appeared under loans to "other financial institutions". At the same date, the net balance on repos and reverse repos conducted by MFIs with central counterparties is included in the aggregate counterparts of money "other counterparts".

Section 2 – Monetary base

Section 2 is composed of five tables, containing Italian monetary base statistics from 1962 to 1998. Tables reproduce and integrate information published in “Supplements to the Statistical Bulletin – Monetary Base” up until March 1999, and complete the historical data reconstruction included in April 1992 publication titled “*Le statistiche della base monetaria: fonti, definizioni e metodologie*”, referenced for further methodological details (http://www.bancaditalia.it/statistiche/quadro_norma_metodo/metodoc/suppl_20_92.pdf, only in Italian).

Methodological notes

Table 1 - TDAS0080 - Monetary base: changes.

The tables shows the changes in the channels of monetary base creation from 1962 to 1998. The item "Foreign sector" does not include exchange rate adjustments. The item "Treasury" refers, until December 1993, to drawings on the Treasury current account with the Bank of Italy, and from January 1994 onwards, to use of the Treasury payments account; from December 1994 onwards it also includes drawings on the sinking fund for the redemption of government securities. The proceeds of asset sales are assigned temporarily to the Treasury payments account, from where they are subsequently transferred to the sinking fund for the redemption of government securities. Since 1995 the Treasury has used the balance on this account to buy back government securities. The figure for December 1993 does not include the flow connected with the creation of the Treasury payments account; that for November 1994 does not include the flow connected with the conversion into securities of the balance in favour of the Bank of Italy on the Treasury current account.

The item "Other BI-UIC operations with the Treasury" includes the net purchases of government securities at issue by BI-UIC, Treasury currency in circulation, Treasury currency held by the Bank of Italy, refinanced stockpiling agency bills, sundry services on behalf of the state and other BI-UIC financing net of the banknotes held by the Treasury. The figure for December 1993 does not include the purchases of securities for the creation of the Treasury payments account; that for November 1994 does not include the purchases of securities for the conversion of the balance in favour of the Bank of Italy on the Treasury current account.

The item "Open market" shows the balance of the outright and temporary transactions in securities carried out for monetary policy purposes; the transactions carried out in connection with the special advances granted under the Ministerial Decree of 27/9/1974 and Law 588/1996 are not included.

The item "Refinancing" includes the changes arising mainly in connection with discounting transactions and ordinary and fixed-term advances to the banking system.

The figures for December 1998 refer exclusively to the accounts of the Bank of Italy and not to the consolidated accounts of BI-UIC since that month saw the completion of the transfer to the Bank of Italy under Decree Law 43/1998 and Decree Law 319/1998 of the reserves held by the UIC.

The item "Foreign sector" does not include the correction for exchange rate adjustments; the aggregate therefore coincides with the net foreign position of BI-UIC, calculated at end-of-period prices and exchange rates.

The item "Government securities and securities issued on behalf of the Treasury" shows the amount of securities acquired outright by the Bank of Italy. The aggregate differs from the holdings in the BI-UIC accounts because it includes the securities assigned in connection with advances under Ministerial Decree 27/9/1974 (until September 1991); by contrast, as in the BI-UIC accounts, the aggregate does not include the securities assigned in connection with special advances under Law 588/1996. The year-end figures include the writedowns of the securities. The figure for December 1993 includes the securities, amounting to 30,670 billion lire, issued by the Treasury for the creation of the Treasury payments account; in addition, from 1994 onwards the aggregate includes the securities issued for the conversion of the Treasury current account in accordance with Law 483/1993.

The balance on the Treasury payments account is shown with a negative sign to indicate that it represents a liability of the central bank towards the Treasury, unlike the Treasury current account, which represents a claim on the Treasury. The proceeds of asset sales are assigned temporarily to the Treasury payments account, from where they are subsequently transferred to the sinking fund for the redemption of government securities (Law 432/1993).

"Other items" include Treasury currency in circulation, claims arising from the conversion of compulsory stockpiling bills, Treasury currency held by the Bank of Italy, sundry services on behalf of the state, other BI-UIC financing net of banknotes held by the Treasury. From 1/1/1994 to 14/11/1994 they also include the balance of the suspense account under Law 483/1993 (for the conversion of the Treasury current account).

This Bank of Italy claim on the Treasury was subsequently converted into long-term government securities, in accordance with Law 483/1993.

The item "Net Open market temporary operations" shows the balance between repos and reverse repos. From July 1994 onwards these operations were extended to Treasury certificates in ecus (CTEs); these securities were valued at the lira/ecu exchange rate of the day the transactions were carried out.

The item "Discounts and other items" includes all the special advances granted from April 1997 onwards (Ministerial Decree of 27/9/74 and Law 588/1996).

For the sake of accounting consistency and as for the item "Foreign sector", the total of the item "Other sectors" does not include exchange rate adjustments.

The item "Currency in circulation" includes other minor non-bank deposits.

From October 1990 onwards the item "Compulsory reserves" comprises the average reserve requirement in the maintenance period (from the 15th of the month indicated to the 14th of the following month); previously it comprised the compulsory reserves in respect of funds raised in lire.

Until September 1990 the item "Excess reserves" comprised the freely available reserves; from October 1990 onwards it represented the excess with respect to the average requirement on the reserve accounts and the freely available deposits of banks not subject to the reserve requirement.

The item "Other deposits" (Bank reserves) includes the so called "depositi per debordo massimale sugli impieghi", which are deposits that banks are asked to post when their loans exceed a predefined ceiling, and the compulsory reserves on net foreign currency fund-raising.

The item "Other reserves" includes reserves different from those held in cash, for example reserves held in securities.

The table contains estimates for the various reserve maintenance periods (from the 15th of the month indicated to the 14th of the following month). The figures for December 1998 refer to the maintenance period 15-31 December 1998.

Until September 1990 the item "Bank deposits with the Bank of Italy" included compulsory reserves, freely available deposits and deposits backing banker's drafts; from October 1990 it included the reserve account, the freely available deposits of banks not subject to the reserve requirement and deposits backing banker's drafts. Until May 1991 it included the compulsory reserves on net foreign currency fund-raising.

The data on "Banks' vault cash" are estimates based on banks' ten-day reports.

The rates of growth in bank reserves and in total monetary base are calculated with reference to the series adjusted for the change in the average compulsory reserve ratio. The purpose of the adjustment is to obtain an aggregate for bank reserves that has a relationship with the money supply that is stable and, in particular, that does not depend on changes in the average reserve ratio. The aggregate is obtained by correcting the raw flows of bank reserves for the change in the average reserve ratio, multiplied by the stock of bank deposits. The cumulative sum of the adjustment flows is then deducted from the compulsory reserves, the bank reserves and the monetary base to obtain the corresponding "adjusted" series. For more detail on the method of calculating the adjustment, see "Le statistiche della base monetaria: fonti, definizione e metodologia", in "Supplementi al Bollettino Statistico. Note metodologiche e informazioni statistiche", no. 20, 1992.

As of January 1997 the rates of growth are calculated as percentage ratios of adjusted flows to the unadjusted stock, to prevent the large adjustment accumulated between 1994 and 1996 from distorting growth rates downwards. The figure for December 1998 was adjusted to take account of the effect of the anomalous duration of the last maintenance period of the year.

As of July 1994 transactions involving CTEs are included; these securities are valued at the lira/ecu exchange rates obtaining on the days the transactions were carried out.

DISCOUNT RATE

The figures refer to the official discount rate at the end of the period.

From 1893 to 1936 there were three different discount rates: an "official" or "normal" rate, a "reduced" rate and a "preferential" rate. The time series shown in the table refers to the "normal" discount rate, whose definition is closest to that of the official discount rate used in subsequent years.

From 1969 to 1986 the value corresponds to the “base” rate and does not include the increment applied to banks that had either used discount operations in the previous six-month period for average amounts exceeding 1 per cent of their customer deposits subject to the compulsory reserve requirement or discounted promissory notes with specific characteristics. Additional information is provided in the notes to the table showing the Bank of Italy official interest rates (*TAMS0300*).

INTEREST RATE FOR ORDINARY ADVANCES

The figures correspond, from 1950 to 1998, to the interest rate applied to the amount drawn of the ordinary advances the Bank of Italy granted to banks for liquidity management purposes.

INTEREST RATE FOR FIXED-TERM ADVANCES

The first fixed-term advances were granted in July 1967; up to March 1969 the interest rate applied to these operations was the same as that applied to ordinary advances. Subsequently, penalties were added to the base rate in relation to the frequency with which banks used this type of financing.

Up to 1990 the data published correspond to the average of the interest rates for the actual transactions outstanding at the end of the reference period. From 1991 onwards, they correspond to the base rate, plus the increment, regardless of whether there were any fixed-term advances during the period or not. From this time onwards, the interest rate for fixed-term advances became an official rate and marked the upper limit of the so-called “corridor of official rates”.

MARGINAL INTEREST RATES FOR OPEN-MARKET REPO OPERATIONS

The interest rates shown correspond respectively to the minimum rate accepted at repo auctions and the maximum rate accepted at reverse repo auctions, from 1981 up to 1998. The absence of figures for a period indicates that no operations of the kind were carried out during the reference period.

TAMS0300 –Bank of Italy official interest rates: 1936 - 2003

From 1936 up to 1991 Bank of Italy official interest rate changes were implemented with a decree issued by the Minister of the Treasury.

The official discount rate was applied to the discounting of banks' ordinary portfolios. From 1969 onwards an increment to the base rate was fixed and applied to banks that had either used discount operations in the previous six-month period for average amounts exceeding 1 per cent of their customer deposits subject to the compulsory reserve requirement or discounted promissory notes with specific characteristics. This increment was definitively abolished in 1986.

Law no. 82 of 7 February 1992 provided for changes in the discount rate and the interest rates for Bank of Italy current account and fixed-term advances to be set. In relation to the control of the market's liquidity, by the Governor of the Bank of Italy in a decision to be published in the *Gazzetta Ufficiale della Repubblica italiana*.

Between 1992 and 1998, which coincided with the period of mobilization of the deposits made with the Bank of Italy to meet the compulsory reserve requirement, the official discount rate and the rate for fixed-term advances were respectively the lower and upper limits of the so-called "corridor of official rates".

As of 1 January 1999, with the start of Economic and Monetary Union, the Bank of Italy ceased to set the official discount rate.

Pursuant to Legislative Decree no. 213 of 24 June 1998 (published in *Gazzetta Ufficiale* no. 157 of 8 July 1998), for a period of five years starting in January 1999, the Bank of Italy periodically set an interest rate in lieu of the official discount rate. This rate, known as the "official reference rate for instruments linked to the former official discount rate", was set equal to rate for the Eurosystem's main refinancing operations, the monetary instrument considered to be the closest equivalent to the earlier official discount rate.

Since 1 January 2004, as provided for by the decree referred to above, the Bank of Italy has no longer set the official reference rate.

Section 4 – The Italian financial accounts – from 1950 to 1994

Note to the tables

The tables reconstruct the main items of Italy's financial accounts from 1950 through 1994. The data are in billions of current lire. The statistics are not on a consolidated basis; that is, they are gross of transactions between units belonging to the same institutional sector, like the data being published at present (See the financial accounts supplement to the *Statistical Bulletin*). The information refers to end-of-year stocks and may be revised in the future.

For a full description of the statistical sources drawn on, the methodology used and the composition of the sectors and financial instruments, see Bonci and Coletta, "I Conti finanziari dell'Italia dal 1950 a oggi", paper given at the conference *I conti finanziari: la storia, i metodi, l'Italia, i confronti internazionali*, held in Perugia on 1-2 December 2005; available at www.bancaditalia.it under economic publications (section "Atti di convegni").

This note is intended to furnish relevant information for reading the tables.

In constructing the series from 1950 to 1962 a number of statistical sources have been used: the balance sheets of the Bank of Italy and the Italian Foreign Exchange Office (Ufficio Italiano Cambi, UIC); Istat's *Annuario Statistico Italiano* and *Sommario di statistiche storiche* (1926-1958); statistics published by the UIC; various statistics from government departments; and F. Cotula and M. Caron, "I conti finanziari dell'Italia. Dimensioni e struttura della ricchezza e del risparmio finanziario dell'Economia", extract from Banca d'Italia's *Bollettino* No. 6, 1971.

In reconstructing the financial accounts from 1963 to 1994, the following sources have been used: Caron and Cotula (1971) for the data from 1963 to 1970; the annual reports of the Bank of Italy for the years from 1971 to 1988; the electronic database for the financial accounts prepared to the standards of the European System of Accounts (1979 version), for the years from 1989 to 1994. The last update of this database is available on CD-ROM from the public statistical database (Base Informativa Pubblica), September 2001. The data, originally corresponding to heterogeneous standards of classification for institutional sectors and financial instruments, have been organized for greater continuity, resulting in time series which, though not always reconstructed at market values or on an accrual basis as the European System of Accounts 1995 calls for, do have a classification of sectors and instruments similar to that in use today.

The approach used in the reconstruction, therefore, makes it possible to link the series given here with those published from 1995 on in the "Financial Accounts" Supplement to the *Statistical Bulletin* (annual tables) of the online public statistical database.

For correct updating of the series, a synthetic concordance schema is given below.
